- *Opportunities for board membership among CDCs and health organizations?*
- *Communities of Practice*
 - “Communities of practice are groups of people who share a concern or a passion for something they do and learn how to do it better as they interact regularly” (Wenger-Trayner, 2015, 1).
 - Defined by **three core elements**:
 - **A shared domain of interest** (e.g., community health) defines the group’s identity.
 - **Members of the group form a community**. As community members, they share activities, conversation, and information; they help each other and build relationships.
 - **Members are practitioners** that develop a toolbox of shared resources. In other words, they’re not just linked by a common interest, but a **common practice**.

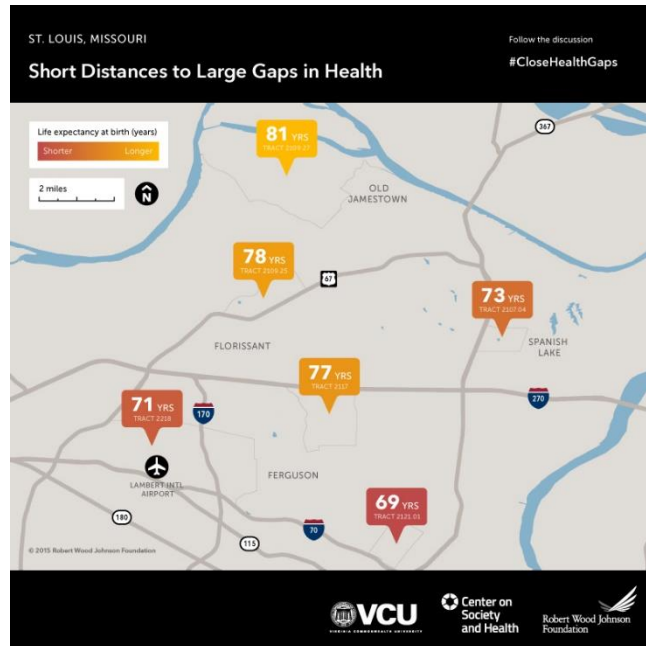
LIFE EXPECTANCY MAPS

- The Robert Wood Johnson Foundation and Virginia Commonwealth University's Center on Society and Health have created a series of life expectancy maps to illustrate the impact of health disparities across neighborhoods. Their map of St. Louis was released earlier this month. It shows that:

- Average life expectancy southeast of Ferguson in **census tract 2121.01** is just **69 years**.
- Eleven miles away in **census tract 2109.27**, west of Old Jamestown, life expectancy is **12 years higher (81 years)**.

- The authors explain that many factors influence neighborhood-level health, including **education and income, quality of housing available, opportunities to exercise, access to medical care, and residential segregation**.
